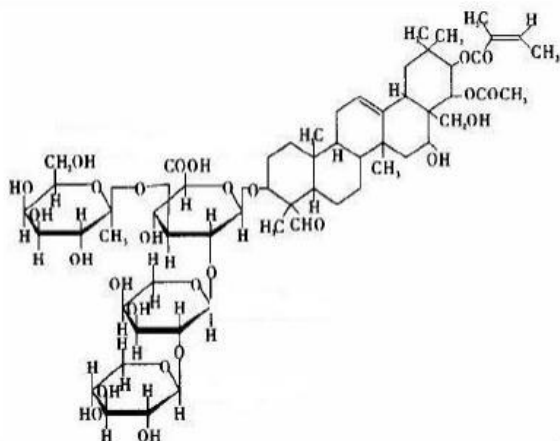

## Section 5 - FIRST AID MEASURES

## Section 6 - FIRE FIGHTING MEASURES

**Special fire and explosion dangers:** None. This is a non-combustible article.
