Appropriate engineering controls	Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. • Certified respirators will be useful for protecting workers from inhalation of particulates when properly selected and fit tested as part of a complete respiratory protection program.

• Use approved positive flow mask if significant quantities of dust becomes airborne.

Information on toxicological effects
